SUBJECT: INVITATION FOR QUOTATIONS FOR SUPPLY OF TABLEAU CREATOR, EXPLORER AND VIEWER LICENCED SOFTWARE WITH ONSITE TRAINING UNDER WBADMI PROJECT.

1. You are invited to submit your most competitive quotation for the Tableau Creator, Explorer and Viewer Licensed Software with onsite training:-

2. Government of India and Govt. of West Bengal received a loan from the International Bank for Reconstruction & Development (IBRD) in various currencies equivalent to US\$ **125 Million** towards the cost of the WBADMI Project and now The Govt. of West Bengal intends to continue the WBADMI Project and apply the fund of the Govt. to eligible payments under the contract for which this invitation for quotations is issued.

3. Bid Price

- a) The contract shall be for the full quantity as described above. Corrections, if any, shall be made by crossing out, initialing, dating and re-writing.
- b) All taxes (like GST etc.) payable on the supplied materials shall be included in the total price.
- c) Sales tax in connection with the sale shall be shown separately.
- d) The rates quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
- e) The Prices shall be quoted in Indian Rupees only.

4. Each bidder shall submit only one quotation.

The Bidder shall indicate on the Price Schedule the unit prices and total bid prices (in Indian Rupees) of the above mentioned supply of software's, it proposes to supply under the Contract. To this end, the Bidders **are not** allowed the option to

submit the bids for any one or more items specified in the 'Schedule of Requirements'. However, **Bidders shall quote for the complete requirement of goods and services specified under all items on a single responsibility basis**, failing which such bids will not be taken into account for evaluation and will not be considered for award.

4.1 Prices indicated on the Price Schedule shall be entered separately in the following manner:

- (i) The price of Goods/Services, quoted delivered to the consignee including GST.
- (ii) GST will be payable on the services if this Contract is awarded; and
- (iii) The price of other incidental services listed in Clause of Conditions of Contract.

4.2 Prices quoted by the Bidder shall be fixed during the Bidder's performance of the Contract and not subject to variation on any account. A quotation submitted with an adjustable price will be treated as non-responsive and rejected.

5. Quotation must be received in the office of WBADMI Project, SPMU, ICMARD Building, Ultadanga, and Kolkata not later than the time and date given in the letter of invitation. If the specified date is declared a holiday, quotation shall be received up to the appointed time on the next working day.

6. Documents Establishing Bidder's Eligibility and Qualifications:

6.1 Copy of Valid 15 digit Goods & Services Taxpayer Identification Number (GSTIN) under GST ACT 2017

6.2 Valid PAN number with self-attested copy of PAN

6.3 Valid Trade License

6.4 Certificate of origin of the equipment/goods offered (if any).

7. Validity of Quotation

Quotation shall remain valid for a period not less than 30 days after the deadline date specified for submission.

GST on Goods/Services shall be taken into account in evaluation if any.

8. Opening of Quotation

Quotation will be opened in the presence of bidders or their representatives who choose to attend on the date and time and at the place specified in the letter or invitation.

Information relating to evaluation of quotations and recommendations for the award of contract shall not be disclose to bidders or any other persons not officially concerned with the process until the award to the successful bidder is announced.

9. Evaluation of Quotations

The Employer will evaluate and compare the quotations determined to be substantially responsive i.e. which

- (a) Meet the qualification criteria specified in clause 6 above
- (b) are properly signed , and
- (c) Conform to the terms and conditions, and specifications and drawing without material deviations.

10.0 Award of contract

- 10.1 The Purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price .
- 10.2 Notwithstanding the above, the Purchaser reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract.
- 10.3 The bidder whose bid is accepted will be notified of the award of contract by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the purchase order.
- 10.4 Payment shall be made in following manner: 100% of payments after completion of successful supply, installation and training duly verified by the concern person of SPMU on receiving the bills in triplicate.
- 10.5 Normal commercial warranty/ guarantee shall be applicable to the supplied material (if any).
- 10.6 Bidders are requested to provide his/their offer letter by **14.00 hrs. Dated 13.01.2022.**

11 Performance Security :-

Security Deposit @ 3% of the total value of the bill shall be deducted at the time of payment or the same can be submitted as Performance Security in the form of Bank guarantee in favor of Executive Engineer and D.D.O., SPMU, WBADMI Project, and Kolkata.

12. Release of Security Deposit:

Security deposit shall be released after two (2) years from the date of completion of supply installation and training of the aforesaid software and after receiving acceptance certificate from the concerned person, SPMU.
