The Government of India has received a credit from the International Development Association / loan from the International Bank for Reconstruction & Development towards the cost of West **Bengal Accelerated Development of Minor Irrigation Project** (WBADMIP) and intends to apply a part of the funds to cover eligible payments under the contracts for construction of works as detailed below. Bidding is open to all bidders from eligible source countries as defined in the *IBRD Guidelines for Procurement*. Bidders from India should, however, be registered with the Government of West Bengal or other State Governments/Government of India, or State/Central Government Undertakings. **Bidders are advised to note the minimum qualification criteria specified in Clause 4 of the Instructions to Bidders to qualify for the award of the contract.**

2. The Executive Engineer, DPMU, WB-ADMIP, Murshidabad invites item rate bids in electronic tendering system for and on behalf of The Project Director, WBADMIP, the construction of works detailed in the table. The bidders may submit bids for all of the following works. Date of release of Invitation for Bids through e-procurement: **13/08/2021**.

3. **The Bid document is available online and bids are to be submitted online through the e-tendering portal <https://wbtenders.gov.in> only. Bids submitted manually will not be accepted. The bidders would be required to register in the web-site which is free of cost. For submission of bids, the bidders are required to have Digital Signature Certificate (DSC) from one of the authorized certifying authorities. Aspiring bidders who have not obtained the User ID and Password for participating in e-tendering may obtain the same by registering in the website: <https://wbtenders.gov.in>**

4. **Bid Security:** Bid Security as shown in the table to be submitted online through NEFT/RTGS by any nationalized/scheduled bank as per e-tendering rules of Govt. of West Bengal.

5. The last Date and time for receipt of bids through the e-tendering portal <https://wbtenders.gov.in> is **13/09/2021** up to 15.00 hrs and will be opened on **15/09/2021** at 12.30 hrs. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue .
